TERMS OF USE AND SOFTWARE LICENSE AGREEMENT

AccessMod 5.0 ("**AccessMod**") is a product developed by the World Health Organization ("**WHO**"), in collaboration with University of Geneva and the AeHIN GIS Lab. AccessMod is available for download without charge from the WHO website.

Please read these Terms of Use and Software License Agreement (the "**Agreement**") carefully before installing AccessMod.

By installing and/or using AccessMod, you enter into an agreement with WHO, and you accept all terms, conditions, and requirements of the Agreement.

1. Third-party Software

1.1. Third-party software needed to use AccessMod. In order to run AccessMod, you will need to download and install the "VirtualBox" software and a modern web browser ("Chrome" is advised, but AccessMod also works on "Firefox", "Safari" and "Internet Explorer"). The "VirtualBox" software can be freely downloaded from <https://www.virtualbox.org>. Additionally, in order to open the results from AccessMod analyses, you will need a software to unzip ".zip" archives.

1.2. WHO disclaimers for third-party software. WHO makes no warranties whatsoever, and specifically disclaims any and all warranties, express or implied, that any third-party software is free of defects, virus free, able to operate on an uninterrupted basis, merchantable, fit for a particular purpose, accurate, non-infringing, or appropriate for your technical system.

1.3. Third-party software user license(s) and use. To the extent you are required to enter into a user license in order to use any third-party software, WHO is not a party to any such license, and WHO therefore disclaims all liability, responsibility, and/or involvement with any such license. WHO shall not be held liable or responsible for either any breach of any of the terms and conditions of any third-party software user licenses by you, or any damages arising from your use of any third-party software.

2.1. Copyright and license. 2.2. Modified Versions to AccessMod. In the event that you convey or otherwise disseminate a modified version of AccessMod:

(i) Your modified work must carry prominent notices stating that you modified AccessMod (as provided for under the terms of the GNU General Public License discussed in paragraph 2.1 above);

(ii) You must include the following disclaimer/explanatory text:

The original AccessMod ver. 5 software is © the World Health Organization.

(iii) Your modified work and your dissemination of it must comply with the terms of paragraph 5.1 below, including, without limitation, that you must not use the WHO name or logo or imply any relation to WHO other than including the disclaimer text of paragraph 2.2(ii) above.

3. Copyright and Terms of Use for the Data

3.1. Copyright of Data. The sample dataset in AccessMod ("**The Data**") is derived from a small region in Malawi. The dataset originates from the Ministry of Health and the Survey Department of Malawi which have both kindly accepted to put their data at disposal to constitute the sample dataset distributed with AccessMod 5.0. For the avoidance of any doubt, WHO hereby asserts its copyright in the Data on behalf of itself and the Ministry of Health and the Survey Department of Malawi, and reserves all rights in the Data.

3.2. Data not part of Software or Published under the GPL. Unlike the Software, WHO is not publishing the Data under the GPL. The Data is an independent and separate work from AccessMod, and is not distributed as "part of a whole" with AccessMod, as those terms and concepts are used in the GPL.

4. Retained Rights and Limitations on Use

4.1. Retained Rights. Except as otherwise indicated herein, WHO owns and shall retain all right, title and interest in and to AccessMod, including all intellectual property rights embodied therein, including (i) all of the service marks, trademarks, trade names or any other designations associated with AccessMod; and (ii) all copyrights, patent rights, trade secret rights, and other proprietary rights relating to AccessMod. Nothing contained in this License shall be deemed to convey to you any title or ownership in AccessMod or the related documentation.

4.2. Technical limitations of Use. You shall not remove any WHO identification or notices of any proprietary, patent or copyright restrictions from AccessMod, or any support material such as the related documentation.

The parties shall accept the arbitral award as final.
